Dear Jeremy,

I am writing to you, alongside key businesses and business groups, to urge the Government to reintroduce VAT-free shopping for international visitors as soon as possible. I wrote to you on this ahead of the Autumn Statement and am compelled to join business voices in pressing you to take action now.

Reintroducing the VAT Retail Export Scheme and airside tax-free shopping will help to increase the number of international tourists who visit London and the United Kingdom, which in turn will provide a much needed boost to businesses and high streets across the country.

Our rich ecosystem of shops, hospitality venues, and cultural attractions, is heavily dependent on both domestic and international tourists. That is why together, London's business groups and I have repeatedly called on the Government to support the return of international tourists back to London, in what is a highly competitive international market, by reinstating tax-free shopping for overseas visitors and also extending this to EU visitors.

London's success in attracting overseas visitors is vital not just to the capital, but to the whole UK economy. London is the gateway to the rest of the UK, for example, 40% of international visitors to Scotland arrive via London and stay in London at the beginning or end of their trip. While much tax-free shopping takes place in London, the negative impact of not having this scheme in place will be felt across the UK, with over 20% of the annual £3.5 billion tax-free snape outside of the capital.

In your statement to Parliament on  $17^{th}$  November, you announced that 'we will no longer be proceeding with the new VAT-free shopping scheme for non-UK visitors, saving a further £2 billion a year'. However, the recent Oxford Economics Study into the impact of tax-free shopping in the UK suggests that the full impact of the policy on Treasury revenues would be a net positive of £350m each year. We are therefore requesting you ask the Office of Budget Responsibility to undertake an independent assessment of the full impact of tax-free shopping on the UK economy and tax revenues, so that decisions can be made based on full and accurate information.

The return of VAT-free shopping would provide a much-needed boost to London's retail and hospitality sectors at a time they need it most. The Prime Minister has stated that his ambition is to grow the economy this year, and the Government should be looking for

ways to secure the capital's status and reputation as a global city that is open to visitors and investment – not providing reasons for tourists and businesses to look elsewhere.

We are therefore urging you to consider the reintroduction of tax-free shopping to support London and the whole UK economy ahead of the upcoming Budget.
