

Estimated additional spending and jobs - regional and national breakdown

AIR estimates that in 2024:

- the UK lost around £2 billion in spending as non-EU international visitors diverted their spending to France, Spain and Italy.
- In addition, EU visitors would have spent £3.65bn in the UK based on evidence of British visitors shopping tax-free in the EU, 50% of which would be spent outside London.¹

This paper is AIR's estimate of the regional breakdown of this £5.65 additional spending if Britain offered taxfree shopping to all international visitors

- i) Regional share of additional £2bn of non-EU spend on shopping
- ii) Regional share of additional £3.65bn of EU spend on shopping, accommodation, hospitality, travel, leisure
- iii) Combined additional spending per region
- iv) Combined additional jobs created per region, based on 1 job per £50,000 spend

Non-EU additional spend per region is based on 2019 tax-free shopping spending per region. HMRC estimated that in 2019, 80% of VAT RES refunds were on sales made in London; 10% on sales at Bicester Village; and 10% for the rest of the UK .Outside London, Edinburgh was the largest City for tax free sales (£92 million), followed by Manchester (£60 million), Liverpool and Ellesmere Port (£32 million), Glasgow (£23 million), Leeds (£18 million) and Birmingham (£14 million). Many other cities such as Cambridge, York, Cardiff, Bath, Southampton, Brighton, Sheffield and Newcastle also register tax-free sales of between £5-10 million.²

EU additional spend per region is based on the percentage spent in each region of the total EU spent in the Uk in2024, as reported by VisitBritain
